Updating IM Information

- Please make sure all information for Out of School Suspension(OSS) and expulsions are updated before the June 22, 2020.
- Data submission opens on May 13, 2020-June 22, 2020 at 9:00 am.
- Make sure you update any In School Suspension (ISS) incidents that were not served due to COVID-19. Updated the ISS code to Behavior Intervention-Add note ISS not served due to COVID-19 School Closure.
- Pending Expulsion for a gun and violent incidents will remain pending until a hearing is conducted. These incidents should not be removed from Incident Management.

Updating OSS with Days Served

- Select the Incident.
- Then select the pencil icon to edit action of Out of School Suspensions (OSS).
- Update the Action Date Range to the actual day(s) served before the school closure.
- Update the Actual Duration Date to the actual day(s) served.
- If you want to keep a record of the prior consequence, then update the Assigned Duration. (This will include the number of days assigned) and Actual Duration (This will include the actual day(s) served).
- Update the Duration Notes-Waived due to COVID-19-School Closure.
- Please double-check the student's attendance to make sure no OSS days are reflected during the school closure dates.

Updating OSS with No Days Served due to School Closure

Updating a Suspension with no days served because of COVID-19-School Closure. (Do not delete the incident.)

- Select the Incident.
- Then select the pencil icon to edit action of OSS.
- Change action from Suspension OSS to Behavior Intervention
- Update the Action Date Range to the dates the OSS date was assigned.
- Select the Blank under Duration Code (No duration times or day should be selected).
- Update the Action Change Reason "OSS waived due to COVID 19-School Closure".
- Please double-check the student's attendance to make sure no OSS days are reflected during the school closure dates.

Updating Suspension Pending Expulsion

- Select the Incident.
- Then select the pencil icon to edit action of Out of School Suspension (Pending Expulsion).
- Update Pending Expulsion to a Suspension for the day(s) served.
- If a district wants to document that a recommendation for expulsion occurred. Please use the Recommended for Expulsion (REX) code in Incident Management. (REX- is used when districts are tracking students recommended for expulsion regardless of the outcome).
- Update the Action Date Range and Duration Code with date(s) served as Out of School Suspension days.
- Update Action Change Reason to "Pending Expulsion waived due to COVID 19-School Closure".
- Please double-check the student's attendance to make sure no OSS days are reflected during the school closure dates.



- All incidents of Truancy should be coded by June 22, 2020.
- Code all interventions that are completed at this point.
- Include any other documentation on the incident that was completed:
 - Letter to Parent
 - Call to Parent

Chronic Absenteeism Updates

Chronic Absenteeism (CA) Data

- Run reports on the district's last day of school.
- Double-check the CA No Show Report in ADT.
- No attendance should be entered after March 13, 2020. All students are marked present.
- All data must be updated by June 22, 2020.

Chronic Absenteeism Reminders

- Please make sure the following steps are followed before submitting data to SCDE:
 - Run the SC 37 Chronic Absenteeism Update Process for all schools in the district.
 - Run the SC 38 Chronic Absenteeism School Level Report (pdf version) for all schools in the district.
 - Review the school membership days at the top of the SC 38 Chronic Absenteeism School report to ensure the information is updated to the current collection cycle
 - Review the report to ensure that the students are reported accurately.
 - Review the entry and exit dates for students identified to ensure that this information is correct.
 - Review the reports to ensure that "No Show" students are not reported.
 - Compare the ADT reports to SC 38 Chronic Absenteeism School Level Report (pdf version) for all schools in the district.

Dropout Reminders

- Please keep documentation for all students who transfer during this timeframe.
- Keep records for all homeschooling transfers.
- SC Dropout Report 2018-19 will be available in June in a new webpage format.
- Dropout Policies and Procedures document 2019-20 will be available at the end of May 2020.
- GED Completers list and Adult Education Diploma list will be available in June in ADT. (October 2019-May 2020)




